

## ACRONYM AND TERM GLOSSARY

**Help Me Grow** is a system that supports Alameda County families with children birth to age 5 by training providers to do developmental screening and follow-up, providing direct access to developmental screening, providing information on child development and developmental milestones, and providing referrals and family navigation for resources and services. Help Me Grow also works to increase collaboration among providers and systems working with families with children birth to age 5.

Autism Spectrum Disorders (ASD)	Autism spectrum disorder (ASD) and autism are both general terms for a group of complex disorders of brain development. These disorders are characterized, in varying degrees, by difficulties in social interaction, verbal and nonverbal communication and repetitive behaviors. With the May 2013 publication of the DSM-5 diagnostic manual, all autism disorders were merged into one umbrella diagnosis of ASD.
BCBA	Board Certified Behavioral Analyst is a specialist in evaluating behavior and developing behavior plans, and one who has met standards for

Basic Needs	These are services that address the most basic needs a family has such as those for food, clothing and shelter.

Evaluation	Evaluation consists of the procedures used by qualified personnel to determine a child's initial and continuing eligibility for services such as Early Start or special education.
Family-Centered	An approach to providing services that recognizes that each family is unique; that the family is the constant in the child's life; and that they are the experts on the abilities and needs of their child and family. The family works with service providers to make informed decisions about the services and supports the child and family receive. In family- centered service, the strengths and needs of the family are considered.
Family Advocate	Usually a person who works for a community-based agency and provides family support services, helping families link to resources and achieve their goals. Many Head Start programs have family advocates who work with the families who children are attending their preschools.
Family Member	A person, who has provided primary support for, is a primary caregiver of, or whose daily life is impacted by a person who is living with developmental delay, social emotional concern or disability. Family members may be the biological parents, foster parents, siblings, spouses, children, aunts, uncles, cousins or friends.
Family Navigators (FN)	Family Navigators in Help Me Grow are staff that provide family support, assistance and resources. Services are in-person or by telephone and may include working together to support family needs and goals; information and referrals to other community resources; connecting families to services and making sure families receive services at home or in the community such as early intervention services, mental health services, community services, and developmental services; and communication with other providers serving the child. Family Navigator is a job title also used in other systems and services and usually involves a staff person who provides support, guidance and resources to families.
Family Partner	A family partner is usually a staff person who works for a community- based agency (in our county they are most common in mental health agencies) who have lived experience and offer support, modeling and

IPP Individual Program Plan	For people who are eligible under the Lanterman Act (Regional Center services over 3), the IPP is a document that lays out what services and supports a person needs and prefers. It also says who will provide those services and supports.
Lanterman Act	The Lanterman Act is the California law that gives eligible people with developmental disabilities (such as autism, intellectual impairment, cerebral palsy and epilepsy) and their families <b>a</b> right to get the services and supports they need to live like people without disabilities. Administered by Regional Center of the East Bay in Alameda County.
LCSW	Licensed Clinical Social Worker. A social worker trained in psychotherapy who helps individuals deal with a variety of mental

Medical Therapy Unit (MTU)	MTUs provide physical and occupational therapy to children who meet CCS qualifications. These services are usually coordinated with those of the school district for children in special education.
Medi-Cal	Medi-Cal is California's Medicaid health care program. This program pays for a variety of medical services for children and adults with limited income and resources. Medi-Cal is supported by federal and state taxes.

MFT	Marriage and Family Therapists are licensed mental health professionals who work with individuals; couples - whether or not

MDT	Multi-Disciplinary Team is a group of people from different disciplines and professions who are experts in different areas for the purpose of

Neurologist	A neurologist is a medical doctor who has trained in the diagnosis and treatment of nervous system disorders, including diseases of the brain, spinal cord, nerves and muscles.
Occupational Therapy / Therapist	Occupational Therapists (OT) work with children on the functional use of their hands (i.e. writing) and mouth (i.e. chewing) as well as on sensory issues. They help children develop and improve their skills.
Pathways	Pathways is the name of the data system that Help Me Grow Alameda County uses to collect information about the work that we do.
PDD NOS	Pervasive Developmental Delay Not Otherwise Specified. This is a diagnosis that was used for significant and ongoing impairments in the
Pervasive Developmental Delay Not Otherwise Specified	development of social interaction or verbal and nonverbal communication skills, or when stereotyped behavior, interests, and activities are present, but the criteria are not met for a specific PDD. Not as frequently used since 2013.
Physical Therapy / Therapist	Physical therapists (PT) work with children on the functional use of their bodies, particularly their large (or gross) motor skills. They work on issues like walking, climbing stairs and balance to develop and improve these skills.
Prevention	Interventions that reduce the possibility of a child developing a more severe or lifelong disability, mental illness, special health care need or developmental delay.
Promising Practice	A service delivery model that shows signs of becoming a best practice, but has not yet been fully evaluated.
RCEB	Regional Center of the East Bay. A private, non-profit corporation

Regional Center of the East Bay R&Rs	providing services and supports to individuals with developmental disabilities under contract with the California Department of Developmental Services. Administers the Early Start and Lanterman in Alameda/Contra Costa counties. Regional Centers delivers services in both Early Start and Lanterman through funding programs in the community to serve a client. These community programs are 'vendors' of the regional center. Child Care Resource and Referral Agencies. The California Department of Education funds R&Rs throughout the state to help parents find child
Child Care Resource and Referral Agencies	care and to support child care providers. The R&Rs for Alameda County are BANANAS, 4Cs & Child Care Links.
Screening	Screening is a short process designed to determine if a child is on track with key developmental milestones and to identify developmental and/or social-emotional concerns needing further assessment or evaluation from local early intervention (such as Regional Center Early Start), early childhood special education, health, or mental health agencies.
SELPA	There are 5 SELPAs in Alameda County- MAC (Mid Alameda County), NRSELPA (North Region), Oakland, Tri Valley and Mission Valley. All
Special Education Local Plan Area	school districts belong to a SELPA. SELPAs develop plans to serve the special education needs of children in a particular area. Some SELPAs play roles in dispute resolution and program development.
Service Provider	Individuals, groups, and organizations, including County-operated programs that deliver services to clients and patients
Social Determinants of Health	The social determinants of health are the conditions in which people are born, grow, live, work and age. These circumstances are shaped by the distribution of money, power and resources at global, national and local levels. The social determinants of health are mostly responsible for health inequities - the unfair and avoidable differences in health status seen within and between countries.
Speech and Language Pathologist (SLP) / Speech Therapist / Therapy	Speech and Language Pathologists work with children with speech concerns such as not understanding language (receptive language), not being able to produce sounds well (articulation), not being able to interact with peers (pragmatic language) and not being able to use language to make their needs and thoughts known (expressive language).
Special Day Class (SDC)	A special education class which provides services to students with intensive needs that cannot be met by the general education program or other programs. Classes consist of more than 50% of the student's day.
Special Education	Special Education is usually used to refer to services given to children eligible under the Individuals with Disabilities Education Act.

SSA Social Services Agency	Alameda County Social Services Agency is a county agency that administers CalFresh, CalWorks, Medi-Cal enrollment, other income assistance programs, emergency shelter, and child welfare services.
SSI Supplemental Security Income	Supplemental Security Income are benefits paid to disabled adults and children who have limited income and resources. SSI benefits also are payable to people 65 and older without disabilities who meet the financial limits.
SSDI Social Security Disability Insurance	Social Security Disability Insurance is a federal insurance program that protects workers who become totally disabled and cannot work for a year or more. SSDI cash benefits are paid to disabled workers who earned enough work credits and worked recently enough to qualify. SSDI also provides cash benefits for eligible family members.
SST Student Study Team	A student study team (SST) is a general education process in schools where a multidisciplinary team review ways to better support a student in general education for academic success.
State Status 2	Refers to State of California, its departments and/or agencies Children eligible for regional center services under Lanterman are
	designated status 2 (usually after age 3).
Strengthening Families	A framework of five protective factors, based on extensive research, to promote optimal child development and strong families. Programs across the country are using this framework in how they deliver services and how they work with the community and families. The five protective factors are (1) Parental Resilience, (2) Social Connections/we all need friends, (3) Concrete Support in Times of Need/we all need help sometimes, (4) Parenting is Part Natural and Part Learned, and (5) Social and Emotional Competence of Children.
System(s) of Care (SOC)	Systems of care is a service delivery approach that builds partnerships to create a broad, integrated process for meeting families' multiple needs. This approach is based on the principles of interagency collaboration; individualized, strengths-based care practices; cultural competence; community-based services; accountability; and full participation of families and youth at all levels of the system. A centralized focus of systems of care is building the infrastructure needed to result in positive and equitable outcomes for children, youth, and families.
Therapeutic Preschool	A preschool setting for children with significant social emotional challenges, usually funded by Medi-Cal or a child's school district.
Threshold Language	The most common languages used in a specific geographic area in addition to the primary language (English). Alameda County has four threshold languages: Spanish, Cantonese, Vietnamese, and Mandarin.
Title IV-E	Title IV-E - Federal Payments for Foster Care and Adoption Assistance. Federal block grants to states for aid and services to needy families with

children and child welfare services, including foster care and adoption
placement assistance.
